Examinations (COVID-19)

Theory Examination

Written exam can be taken and invigilated via Zoom or similar platform.

Before exam commences students must show the invigilator their exam area to ensure no book or charts are visible.

A written paper will be emailed to students 15 minutes prior to the commencement of the exam.

At the end of the exam students will scan their completed examination papers and send to the School Principal within 15 minutes.

External Verification

The examination will be marked by your School Principal Tutor and then forwarded to an IFPA external invigilator for external verification.

Throughout your course you will be assessed, tested, monitored and mentored so that you feel fully confident in your knowledge prior to taking the final examination so there is no need to be worried about this as we will make sure you are ready.

Practical Massage Examination

This will be carried out via Zoom or similar platform which will be recorded. We will use Zoom breakout rooms, this gives the examiner the freedom to ask students questions without disturbing other students.

The student will be assessed on completion of the client consultation form, selection of aromatherapy products chosen for the client and reasoning, care of the client, professional appearance and manner as well as the massage itself.

External verification

The online examination will be recorded and sent to an IFPA approved Assessor for final verification.

Full Professional Aromatherapy Diploma in house course from £3000

The course runs for a minimum of 10 months and up to 24 months for completion. There are around 30 in house days spread in blocks of 3, 4 or 5 days. You will be personally taught in a small group of no more than 6 students to guarantee the highest level of training. We will teach you everything we know as practicing aromatherapists and help you to understand what you need to do to start your own successful business.

You will be assessed during the course via online tests, multiple choice questions, essays and in-house assessments. You will need to sit a final exam on ZOOM which lasts approximately 2.5/3 hours.

Aromatherapy Products

It is necessary to buy from professional aromatherapy suppliers. Please do not buy from big multi-level marketing companies (MLM's). the reason for that will be covered on your course. Please buy organic where possible as it does make a difference. Always ask for proof of certification as some may say that they are organic.

We have selected the suppliers that I believe offer the best aromatherapy products. On this course we will cover many and they all have varying prices. To get going I recommend you buy the following products and then choose additional ones as you study them to see what appeals to you. It's important that you buy the right product as there are various species so, do observe the Latin names when buying.

We recommend that you look on the Aromatherapy Trade Council website for approved aromatherapy suppliers here.

Formulation and Making Organic Skincare

At the end of this course, you will become a Professional Aromatherapist with an internationally recognised qualification. You will be able to treat people using individual client consultations with signed consent from them.

This course does not cover being able to make and sell water based products to the public which would require that your products must comply to cosmetic testing. If you are creating your products properly you shouldn't have a problem with anything, but it is a legal requirement to have proof that your products meet the standards.

We will teach you how to make anhydrous products which are based around oils, waxes and butters and contain no water which do not require challenge testing.

Here is what the EU cosmetic regulation says.

'Developing your cosmetics

Manufacturing according to Good Manufacturing Practices (GMP)

The EU Cosmetics Regulation stipulates that all cosmetics products must be manufactured in accordance with the harmonised standards laid out in GMP, in turn described in the

Official Journal of the European Union. GMP ensures that products are prepared in a clean environment and that the products are not contaminated in production. Microbial contamination can be quite common as many microorganisms live freely in the atmosphere around us, and could lead to degradation and, in severe cases, could cause harm to the consumer.

Placing a product on the market

Europe

Before being placed on the European market, all cosmetics products must be listed on a centralised database, the Cosmetic Products Notification Portal (CPNP), managed by the European Commission. When a product has been notified in the CPNP, there is no need for any further notification at national level'

UK 2020

Office for Product Safety and Standards (OPSS).

If you are making cosmetic products available to consumers in Great Britain (GB: England, Scotland, and Wales), you must notify your cosmetic products using the Submit cosmetic product notifications service.

The IFPA do not require you to hold a First Aid at Work certificate but, we do highly recommend that you do gain this qualification if you are going to run a business with hands on services.

Cancellation, Deferring and Payment Policy

You are required to pay your course fees at the time of booking. Our Aromatherapy Diploma can be paid in one lump sum or spread over 6 monthly payments which costs slightly more. All short courses must be paid in full at the time of booking. Course fees are non-refundable once your course has commenced. You may be able to defer the start date of your course at your Tutor's discretion.

Refunds Policy
